This circular provides information on HEFCW's part-time undergraduate fee waiver scheme for 2024/25, including the allocation of £200k total funding to institutions, and sets out the criteria students will need to meet in order to be eligible for a fee waiver under the scheme. The funding in this circular relates to academic year 2024/25, which extends beyond the expected remit of HEFCW, but in light of the ambition to ensure a smooth transition, we anticipate Medr (the Commission for Tertiary Education and Research) will honour the funding commitments made here.

The Higher Education Funding Council for Wales (HEFCW) will cease operating after 31 July 2024. HEFCW's duties, responsibilities and staff will transfer to Medr, the <u>Commission for Tertiary Education and Research</u>, from 1 August 2024. Any circulars that require attention after 1 August 2024 will be available on the Commission's website from August.

Introduction

- This circular provides information on HEFCW's part-time undergraduate fee waiver scheme for 2024/25, including the allocation of £200k total funding to institutions, and sets out the criteria students will need to meet in order to be eligible for a fee waiver under the scheme. The funding in this circular relates to academic year (AY) 2024/25, which extends beyond the expected remit of HEFCW, but in light of the ambition to ensure a smooth transition, we anticipate Medr (the Commission for Tertiary Education and Research) will honour the funding commitments made here.
- 2. Funding is available in 2024/25 to be administered by institutions currently funded by HEFCW to students who meet the criteria of the scheme, as outlined in this circular. Funding is provided to encourage growth in part-time student numbers and allow part-time students to access and benefit from higher education.
- 3. Institutions are encouraged to advertise the funding available widely in order to maximise the number of students who are able to benefit and subsequently enrol on a part-time course which meets the scheme course criteria.

Details of the scheme in 2024/25

- 4. We have made no changes to the way the scheme will operate in 2024/25 compared to 2023/24.
- 5. The individual institutional allocations are provided in **Annex A**. As for 2023/24, we have included a floor of £2.5k to ensure all funded institutions are able to benefit from the scheme. We have also included a ceiling of £50k in 2024/25 to allow a fair distribution of funding. In addition, for 2024/25, once ceilings and floors are applied, remaining funding is redistributed pro rata to fee waiver usage in 2022/23 based on verified data.
- 6. The allocations have been calculated on a pro rata basis to the number of students considered to be from groups under-represented in higher education (HE), using data extracted from the Higher Education Statistics Agency (HESA) student record. The following criteria have been used as a proxy for assessing whether a student is considered to be from a group which is under-represented in HE: students in the bottom two quintiles of the Welsh Index of Multiple Deprivation 2019; students from areas with low participation in HE; carers, care leavers or care experienced students; students with disabilities; students whose parents do not have a higher education qualification; students from ethnic minority backgrounds. The eligibility criteria are outlined in paragraphs 10-12.
- 7. Intensity of study will normally be measured in credit values. A fee waiver should not be provided for any student who studies 30 credits or more in one academic year. In the situation where a student initially undertakes fewer than 30 credits but subsequently adds to this during the academic year, any fee waiver given would not be regarded to be part of the HEFCW scheme. However, we would encourage providers to continue to provide that fee waiver from other sources, where

possible, in order not to discourage students who decide they would like to study more credits. In all cases, institutional academic regulations will apply.

Commission for Tertiary Education and Research (Medr)

- 8. On 8 September 2022, the Tertiary Education and Research (Wales) Bill became an Act. The Act outlines arrangements to establish the new Commission for Tertiary Education and Research (to be known as Medr), which will replace HEFCW, and will be responsible for regulating and funding most post-16 provision in Wales. It is anticipated that Medr will be operational, and HEFCW will be dissolved, by 1 August 2024.
- 9. We anticipate that financial commitments made by HEFCW will be honoured by Medr, which will include arrangements for monitoring and reclaim of funds where there is an underspend. We expect Medr to make the payments from this scheme to institutions in September 2024. Should we have to amend this profile, we will inform institutions as soon as practically possible.

Student eligibility criteria

- 10. A student enrolled on an eligible course must:
 - (i) be classed as eligible for funding according to the definition provided in HEFCW's Higher Education Students Early Statistics (HESES) survey
 - (ii) be Welsh domiciled (provision of a Welsh address by the student would usually be considered sufficient evidence of Welsh domicile).

and meet one or more of the following conditions:

- a) the student or the student's family¹ is in receipt of: <u>Universal Credit</u> or its predecessors² <u>Jobseeker's Allowance</u> <u>Employment and Support Allowance</u>
- b) the student is in receipt of: Carers allowance or carer's credit Disability premium or other disability-related financial support Bereavement benefits³
- c) the student is from a group which is considered to be under-represented in higher education, such as:
 - students of all ages from areas in the bottom two quintiles of the Welsh Index of Multiple Deprivation 2019

- students of all ages from areas of low participation as measured by the proportion of working age adults with HE qualifications from the 2021 census (bottom two quintiles). Note that this data is currently only available for England and Wales with equivalent data for Scotland and Northern Ireland due to be published later in 2024
- care leavers or care experienced students
- students with disabilities
- students from ethnic minority backgrounds
- LGBTQ+ students
- refugees and asylum seekers
- students with caring responsibilities
- those studying through the medium of Welsh
- 11. It is for institutions to assess the eligibility of students applying for fee waivers, and to devise a fair and equitable process for administering funds under the scheme. It is our general intention that institutions should allocate funds to students who meet the criteria above and who would benefit from undertaking part-time higher education. Information on identifying under-represented groups in higher education can be found in HEFCW's Fee and Access Plan guidance.

Course eligibility criteria

- 12. To satisfy the eligible course requirement, a student must:
 - (i) be studying part-time at an intensity greater or equal to 3% and less than 25% of a full-time equivalent student. The definition of part-time study is that used by HEFCW in its <u>2023/24 HESES survey</u>. This will be measured in credit values relative to an assumed standard 120 credit year for a full-time undergraduate student and so equates to studying fewer than 30 credits for the academic year of the fee waiver. In the event that any student studies 30 or more credits over the academic year they will cease to be eligible for the HEFCW part-time fee waiver scheme but providers are encouraged to continue providing that fee waiver from other sources.

HEFCW recognises that part-time students do not necessarily follow a course of study on a traditional academic year basis. However, for administrative simplicity the grant scheme will be based on the academic year for HE providers, i.e 1 August to 31 July.

(ii) be registered, as a new entrant in 2024/25 or a continuing student, on a programme with the aim of obtaining a recognised undergraduate higher education qualification⁴; or on a course, module or unit (including micro-credential provision) which enables credit to be obtained which could be counted towards a recognised undergraduate higher education qualification. Institutions should contact HEFCW or Medr for clarification in the case of doubt as to what is considered to be in scope.

Non-credit bearing courses and postgraduate courses do not qualify for the scheme.

Students are not eligible for funding to repeat a course or any modules or units in a course, except in cases where extenuating circumstances may apply. Providers should contact HEFCW or Medr for clarification in these cases.

(iii) be studying on a course which corresponds to five credit values or more as defined by the <u>Credit and Qualifications Framework</u> (CQFW).

Credit values are determined on the basis of the CQFW standard of 120 credit values equalling one academic year of higher education experience for full-time undergraduates.

Administration of the scheme

- 13. In order for an institution to issue funds to students via the fee waiver scheme, the provider must be satisfied that the eligibility criteria have been met in relation to (i) the student's course, and (ii) the student's personal circumstances.
- 14. Institutions should record the eligibility criteria prior to fees being waived. If documentation was required to prove eligibility for a fee waiver (e.g. receipt of benefits) the provider should retain evidence of that documentation for audit purposes. Medr may wish to audit the eligibility criteria used and evidence gathered at a later date, in addition to monitoring using HESA data at the end of the academic year.
- 15. Student status should normally be assessed at the beginning of a programme of study. It should then be reassessed at least once every twelve months thereafter, for the duration of the period of study.
- 16. Only tuition fees are eligible for fee waiver. The cost of any assessment or examination fees, additional to those included in the tuition fees, is not eligible under this scheme.
- 17. Funded institutions offering fee waivers under this scheme will be supported through funding from Medr. We encourage providers to operate and promote other schemes to recruit and support part-time students using, for example, support arrangements as identified in fee and access plans.
- 18. Some cases will fall on the margins of the eligibility criteria set out above. In such cases where the award of a fee waiver in the view of the provider would be clearly meeting the overall purpose of the scheme, providers may apply reasonable discretion when testing student eligibility. It is important that the reason for applying discretion is recorded by the institution, as this may be audited by Medr at a later date.

19. Funding can only be provided in support of waived tuition fees for those students who are deemed eligible for the HEFCW part-time undergraduate fee waiver scheme, as set out above, and within the total funding available. Fees may be waived to the full cost of the course's tuition fees, or as a partial waiver. All grants paid must be used for the purposes for which they are provided.

Changes in circumstances

- 20. A material change in circumstances may result in a student becoming, or ceasing to be, eligible for fee waiver during a period of study. Where such a case arises, the provider should seek to waive, rebate or claim fees, as appropriate. Providers should require students to notify them if such a material change in their circumstances arises.
- 21. A student may decide to change from a full-time to a part-time mode of study. If this change in status results in the student meeting the eligibility criteria then, where it is practical, the student should be able to benefit from the scheme. Such a case must be dealt with in the same way as any other significant change in circumstance.

Monitoring and reclaim of funds

22. Institutions are required to return the data relating to part-time fee waivers on the HESA student record, as described in paragraphs 24-31 below. Where institutions have not spent their fee waiver allocation in 2024/25 the funding will be reclaimed by Medr.

Promoting the scheme

23. We would expect providers to promote fee waiver opportunities to those students who this policy is intended to support, particularly those from under-represented groups in higher education.

Allocation and monitoring

2023/24 monitoring

- 24. We are yet to monitor the fee waivers given under the 2023/24 scheme so are including details of how we will do that using HESA student record data here. In order to monitor 2023/24 part-time fee waivers, we will extract data returned by providers on the HESA student record and compare the actual value of fee waivers with the allocation provided for 2023/24. Where the actual value of fee waivers is less than the allocation provided, there will be a reclaim of funds.
- 25. The data are extracted as part of providers' submissions of the HESA student record to Jisc. Providers receive output generated by Medr through the Information

Reporting Interface Service (IRIS). This includes a downloadable part-time fee waiver monitoring table for verification. We require providers to sign off the data in that table with an electronic signature.

- 26. Providers should indicate on the table and in their covering email any changes to their signed off data to account for data errors and return the table to Medr, together with an explanation for the change, as part of the wider return of signed IRIS outputs. Amendments to the table should be made in red. The downloadable table being signed off must be taken from the final IRIS output generated from the final (signed-off) submission of HESA data to Jisc.
- 27. The downloadable table displays information about the amount of fee waived (HESA field StudentFinancialSupport.FINSUPAMOUNT) where the award of a fee waiver has been identified in HESA field StudentFinancialSupport.FINSUPTYPE. Further information can be found on the HESA website in the student record coding manual. Members of staff responsible for the part-time fee waiver scheme should liaise with the HESA student record contact(s) for their institution so that they can download and scrutinise the analysis, check for consistency and look for anomalies that may need to be explained. Once providers are content with the data and any required explanations and amendments, providers should electronically sign beneath the table and email the signed copy to us. The table should be signed by the authorised signatory for the part-time fee waiver data. The names of the authorised signatories are collected annually from providers in the autumn.
- 28. As a cross check, we will also analyse the HESA data when we receive final signed off HESA student record data for all providers.
- 29. Further details will be available in the Data Requirements circular to be published in August 2024.
- 30. The signed IRIS table should be returned to Medr by **13 December 2024 to** <u>hestats@medr.cymru</u>.

2024/25 monitoring

31. Fee waivers awarded for 2024/25 will also be monitored using HESA student record data extracted through the IRIS process, in the same way as for fee waivers awarded for 2023/24.

Timelines

Date	Action
December 2024	Providers download the part-time fee waiver monitoring table from the final IRIS output for 2023/24 and provide it to HEFCW with any amendments or explanations required so it shows the actual value of fee waivers for 2023/24 students. The table should be electronically

	signed by the authorised signatory for the part-time fee waiver data, and emailed to Medr by 13 December 2024 (contact information will be provided in due course). The data expected to be used in allocations for 2025/26 will also be available for sign off as part of the IRIS outputs.	
From February 2025	Medr makes adjustments to 2023/24 allocations following monitoring. Allocations for 2025/26, if appropriate, will be calculated using IRIS output data.	

Assessing the impact of our policies

- 32. As part of our original policy development process we undertook an impact assessment to consider the impact of this scheme on individuals with protected characteristics and groups under-represented in higher education; we keep this impact assessment under review. We will continue to consider the impact of our policies in order to help safeguard against discrimination and promote equality and diversity in HE, and to consider the impact on the Welsh language, Welsh language provision and the potential impacts towards the goals and ways of working set out in the Well-Being of Future Generations (Wales) Act 2015.
- 33. Providers are responsible for reviewing their own impact assessments in relation to part-time funding, taking into account the impact on individuals with protected characteristics and to help safeguard against discrimination.
