Introduction


We are pleased to present our Operational Plan for the 2025-2026 financial year. This document sits alongside our Strategic Plan for 2025-2030, which outlines our ambitious vision for tertiary education and research in Wales.

Our Vision:

We will work in close collaboration with our partners to enable a tertiary education and research system that is centred around the needs of learners, society and the economy with excellence, equality and engagement at its heart.

This Operational Plan sets out the activity we are going to prioritise this financial year to make progress towards the founding and growth commitments in our Strategic Plan, while further establishing ourselves and continuing to transition smoothly from pre-existing arrangements.

All of the activities presented in this Plan have been developed with our strategic aims (our well-being objectives) and our long-term ambitions in mind:



Across the Operational Plan you will see activities that support and address key themes such as equality, Welsh language, participation and learner experience, as well as those that enable us to deliver our critical funding and regulatory role.

We will gather and use robust baseline data to continually review progress towards our strategic aims. We will also use this data to monitor how the tertiary education and research sector is contributing towards Wales' national milestones.

We have prioritised activities to deliver on our founding commitments – setting a twoyear horizon in which to make significant progress. Our ambition is to make substantial progress against all our growth commitments over a five-year horizon.

The activities in this Plan have also been developed, and will be delivered, in line with our organisational values:

Where we refer to learners throughout this Plan, we will consider the needs and interests of the wide range of learners in the tertiary system.

We are grateful for the engagement we have had with stakeholders across Wales during the development of this Operational Plan and look forward to continuing to work in collaboration with the sector on the activity we have outlined. Together we can deliver a resilient tertiary education and research system that is centred around the needs of learners, society and the economy, with excellence, equality and engagement at its heart.

Foundation Aim

To establish Medr as a highly-effective organisation and trusted regulator.



Founding commitments

We will revise our Strategic Equality Plan so that equality, diversity and inclusion are embedded across Medr, supporting the development and well-being of our workforce.

Strategic Aim 1

To focus the tertiary education sector around the needs of the learner.



Founding commitments

We will establish regulatory conditions to advance equity and equality of opportunity. We will work with partners to contribute to eliminating discrimination, harassment, victimisation, gender-based violence and abuse.

We will develop, consult on and publish a condition of funding and registration to advance equality of opportunity and equity in tertiary education, taking effect from August 2027.	April 2026
We will work with the Welsh Government and tertiary education providers to support the delivery of the Welsh Government's equalities-related strategies and action plans, including as they relate to mental health, suicide prevention and self-harm, LGBTQ+, gender, disability, anti-racism, violence against women, domestic abuse and sexual violence, and period dignity.	Ongoing
We will fund and support activities across lifelong learning, improving data collection and sharing practice, to benefit adult community learning, essential skills and ESOL provision.	March 2026
We will evaluate, fund and monitor the Reaching Wider Programme to ensure it contributes effectively to encouraging transition to, and participation in, tertiary education and lifelong learning, particularly amongst groups underrepresented in tertiary education.	July 2026

We will work with the Welsh Government and the sector to make progress towards achieving an anti-racist Wales and ensure inclusive learning and work environments for all, regardless of identity.

We will promote a person-centred approach across the sector to ensure that learners with Additional Learning Needs are able to achieve their potential while receiving support that encourages learner independence.

We will establish regulatory conditions to support learner and staff welfare, building on existing good practice, and strengthened by a common framework for health, mental health and well-being.

We will undertake a scoping exercise with learners, providers and stakeholders to co-construct the requirements for a Learner Voice survey, and undertake an initial pilot with the further education, apprenticeship and adult learning sectors.	August 2026

We will work with providers to ensure that their learners and staff are aware of the opportunities to study, train, volunteer and work globally. We will recognise and celebrate the contribution that international learners and staff make to Wales.

We will work with partners to ensure that the tertiary education system enables learners to be outward-looking, engaged citizens, encouraging participation in activity that develops cohesive communities and enhances our wider civic and cultural life.

We will continue to support the sharing of practice between tertiary providers through our continued support for the Wales Civic Mission Network, including in relation to embedding the learner voice in shaping civic mission activities.	Ongoing

We will work with partners, including the Welsh Government and Careers Wales, to encourage more pre-16 learners to transition to tertiary education and reduce the proportion of people not in education, employment or training (NEET).

We will work with local authorities, schools and FE institutions to review the current transition funding guidance to ensure that funding enables learners to be better informed and confident about their tertiary education pathway choice.	April 2026
We will share our analysis of historical, current and planned tertiary education provision with relevant partners, including Careers Wales, to support the provision of impartial careers advice.	April 2026
We will work in collaboration with local authorities, schools and FE institutions to promote Junior Apprenticeship provision in Wales, working with the Welsh Government to develop enhanced guidance for providers.	April 2026

We will work with partners to promote the benefits of learning throughout life and set targets to increase participation, particularly among those underrepresented in tertiary education, who may face social, economic, cultural or organisational barriers to learning.

We will keep our policy under review, and informed by evidence and data, including the Welsh Government's ESOL review, implement activities to improve English as a Second Language provision.	July 2026

We will develop an evidence base on participation in tertiary education, identifying levels of participation across the tertiary sector by region, drawing on social research and Medr's broader engagement activity.	June 2026
We will engage with the Welsh Government, Qualifications Wales and other partners to ensure smooth implementation of any changes arriving as a result of the review of Essential Skills Wales qualifications.	Ongoing
We will seek to map current transport provision across tertiary education to identify and understand the different approaches and subsequent impact on a learner's access to tertiary education. We will share practice and financial implications with the Welsh Government to support wider transport and budget policy.	April 2026

Strategic Aim 2

To create a flexible and joined-up tertiary system where everyone can acquire the skills and knowledge they need for a changing economy and society.



Founding commitments

We will work with employers and support our providers to make effective use of changing technologies and ensure that learners are equipped for changing industries and ways of working.

We will support and encourage learning providers to seamlessly integrate digital technology into delivery; encourage innovation in using inclusive, accessible and bilingual approaches to enhance the learner's experience; and to equip their staff and learners with the digital capabilities and confidence to succeed in learning, life and work.	March 2027
We will work with providers to ensure they are enhancing the employability of learners in Wales, monitoring effectiveness of current activity and scoping future activity, including the Employment and Enterprise Bureaus in FE colleges and the Targeted Employability Support for Students for higher education students.	Ongoing

We will work collaboratively with the Welsh Government to respond to the skills priorities it sets.

We will work in partnership with the Welsh Government to shape skills strategies for Wales and influence skills system developments at a UK level.	Ongoing
We will take account of research, data and labour market information to better understand the specific and transversal skills needs of Wales to inform our engagement with tertiary education providers, and our funding priorities.	Ongoing

We will develop strong links with business, industry, Regional Skills Partnerships, Corporate Joint Committees and employers to understand the skills needed for a productive workforce. Working with Qualifications Wales and other partners, we will use this intelligence to ensure tertiary education provision responds to the economic priorities of the Welsh Government.

We will establish and build on mechanisms to understand current and future skills needed for a productive workforce across Wales by working collaboratively with key organisations, including the Regional Skills Partnerships and Corporate Joint Committees.	December 2025

We will design future apprenticeship provision to respond to the Welsh Government's skills priorities and to meet the needs of learners, employers and the economy.

We will start a programme of work to review existing frameworks over a 3 year period and introduce a new process to create new frameworks to meet industry requirements.	March 2026
We will develop and consult on a specification, and begin commissioning arrangements for a new apprenticeship programme which will commence in August 2027.	August 2027

We will encourage providers to develop their civic mission and how they share their knowledge for the benefit of our communities. We will work with them to determine how to effectively measure the impact.

We will develop a tertiary education system that allows learners to learn throughout their lives, stimulating flexible approaches to time, place, language, and support for learning.

We will conduct research to explore and understand how credit transfer across tertiary education systems, in other parts of the UK and internationally, is enabling the movement of learners through the system.	December 2026

We will foster collaboration between providers to create coherent and flexible learning pathways that are easy to access and navigate at any point in life. Working with employers, we will support pathways that contribute to a sustainable and resilient Wales.

We will analyse historical, current and planned tertiary education provision to begin to understand gaps and duplication, and providers' responsiveness to learner and economic needs, while encouraging collaboration, through shared practice.	April 2026
We will work with the Welsh Government to support the development and implementation of its revised 16-19 Curriculum Guidance, seeking to ensure accessibility of a breadth of options for all learners in Wales, and aligning to the ambitions of the Curriculum for Wales.	March 2026

We will review the planning, organisation, flexibility and effectiveness of adult community learning, recognising the social and economic benefits of that provision. We will consider how improvements can be made to access, participation and success in essential skills and language provision.

We will work with local authorities to ensure a consistent collection of data to allow for an accurate mapping of ACL provision across both local authorities and FE institutions.	April 2026
We will develop analysis of current and planned ACL provision to understand gaps, duplication and its responsiveness to learner and legislative (section 94) needs to increase literacy, numeracy and digital levels, while encouraging collaboration, evidenced through shared practice.	August 2026
We will work with the Welsh Government to inform the development of regulations under section 94 of the Tertiary Education and Research (Wales) Act 2022.	November 2026

Strategic Aim 3

To ensure learners receive the highest-quality provision in a tertiary education sector that strives for continuous improvement.



Founding commitments

As part of our regulatory system, we will implement a coherent quality framework that is responsive to the diversity of the sector and its learners and has a focus on learner experience and outcomes. We will recognise the need for arrangements that are responsive to differing parts of the sector.

We will continue to monitor the quality of tertiary education in Wales, building upon the expertise of Estyn and the QAA.	Ongoing
We will consult on and publish a Quality Framework, taking account of other inspection frameworks and the European Standards and Guidelines, working in partnership with other bodies and regulators to avoid duplication. The Quality Framework will take effect from August 2026	April 2026
We will develop, consult on and finalise learner protection plan guidance, working with stakeholders, taking effect from August 2026.	April 2026

We will work with partners to ensure our quality framework aligns with necessary inspection and regulatory frameworks in and outside Wales, as well as international standards. We will minimise workload through the avoidance of duplication.

We will consult on and publish a Quality Framework, taking account of other inspection frameworks and the European Standards and Guidelines, working in partnership with other bodies and regulators to avoid duplication, taking effect from August 2026.	April 2026

We will actively promote social partnership in recognition that collaboration between providers and trade unions is mutually beneficial.

To grow internationally-acclaimed research and inspire innovation throughout the tertiary education sector.

We will promote the development of research environments with positive cultures that support integrity, diversity, inclusivity, well-being and respect, that can attract and retain the best researchers and innovators from across the world.

We will manage the delivery of the Wales Research Environment and Culture (WREC) fund which provides institutions with dedicated support for enhancing positive and inclusive research cultures and support for pan-Wales collaborative activities.	March 2026
We will continue to work with key partners to support activities focused on the development of researchers, research-enabling staff and postgraduate research students.	Ongoing
We will work with the other UK funding bodies on the development and implementation of the Research Excellence Framework 2029, including promoting the inclusion of research in the medium of Welsh.	December 2029

We will strengthen our relationships with relevant bodies responsible for research and innovation across the UK to help our providers be successful in growing their share of funding from public and private sources, nationally and internationally, to grow the research base in Wales.
