Dear colleagues,

Funding assumptions for academic year 2026/271

This document sets out, in broad terms, the funding assumptions that underlie the planned distribution of Medr's budget.

These proposals are based on the draft Welsh Government budget published on 3 November 2025 and the subsequent Indicative Funding Letter received on 7 November 2025 (see Annex A).

The final Welsh Government budget is expected in January 2026. Medr expects to publish our final funding allocations at a provider level before the end of March 2026.

The funding proposals in this document are presented with the caveat that the allocations for 2026/27 academic year (1 August 2026 to 31 July 2027) may be adjusted if the Welsh Government revises the 2026-27 financial year (1 April 2026 to 31 March 2027) Medr budget line.

The draft budget was considered by the Medr Board at its meeting on 13 November. Once the final Welsh Government budget has been set, Medr Board will approve any amendments required at its March Board meeting, leading to Medr formalising and publishing our final allocations before the end of March 2026.

Confirmation of the final funding allocations at an institutional/provider level will be subject to the availability of quality assured and verified data used to inform the agreed funding methodologies.

¹ Within this document, financial years are denoted with a '-' and academic years with a '/' e.g. 2026-27 is the financial year and 2026/27 the academic year. Medr receives its budget allocation from the Welsh Government on a financial year basis, but primarily makes allocations to providers for an academic year. The financial year runs from April to March, while the academic year runs from August to July.





The settlement

Details of Medr's draft settlement for the financial year 2026-27 are presented in Table 1. The Welsh Government budget figures are for a financial year from 1 April to 31 March.

Indicative allocation of the Medr budget

In deploying the 2026-27 financial year budget, Medr allocations to tertiary education and research providers are predominantly allocated on an academic year basis. Therefore, the 2026-27 financial year budget must first take account of the known budget requirement to meet the remaining 2025/26 academic year funding commitments placed on Medr. This covers the commitment from April to July 2026.

In the same way, in agreeing 2026/27 academic year allocations, a commitment will be placed on the 2027-28 financial year budget, which has not yet been set by the Welsh Government.

Medr operating costs are not detailed separately in the Welsh Government budget. Before the academic year allocations are derived, Medr's forecast operating costs are deducted.

The Welsh Government has ringfenced a number of funding lines in direct support of specific activity. In 2026-27 this relates to apprenticeships provision (£145,655,000), junior apprenticeship provision (£1,000,000), employability and enterprise (£360,000) and provision to support performance-related music and drama conservatoire (£1,970,000).





The Welsh Government has also provided specific 'steers' as to the deployment of the budget, which are included in the narrative supporting Medr's indicative funding letter and are listed in the table below:

Conversion of financial year budget to an academic year allocation

In most cases this is calculated using a proportion of the current draft FY budget and a balancing proportion of the next year's FY budget. This may vary depending on sector.

These proposals:

- Follow clear steers set out by the Welsh Government in relation to maintaining pay parity between teachers and FE lecturers.
- Align with of Medr's Strategic Plan in allocating all core allocations in line with previously approved funding methodologies.
- Place a cash requirement of £365.828 million on the 2027-28 financial year budget in converting the 2026-27 financial year budget to a 2026/27 academic year allocation.

Welsh Government's budgeted support for Medr, the Commission for Tertiary Education and Research: 2026-2027

Following the publication of the Welsh Government Draft Budget, we are writing to set out the indicative budget for Medr for the 2026-27 financial year.

The funding set out in this letter is intended to assist the Medr board in planning and is subject to approval of the Welsh Government Final Budget by the Senedd. A final funding letter will be issued by Welsh Ministers upon confirmation of the Final Budget, expected in January 2026.

A total resource and capital budget of £1004.522m for the 2026-27 financial year has been identified for Medr, as set out in Annex 1, including ringfenced areas. This is an increase of £25.329m from the revised baseline for 2025-26.

As set out in evidence to the CYPE committee, ministers will expect Medr to utilise the additional funding for the following:

- Continuing pay parity in further education colleges and school sixth forms.
- Addressing growing costs of additional learning needs (ALN) support in further education colleges (£4.1m).
- Support for universities with the costs of Initial Teacher Education (ITE) placements (£2.5m).
- An increase to the Financial Contingency Fund (FCF) in further education (£0.4m).
- Further expansion of junior apprenticeships (£0.4m).
- Assumption of Medr's responsibilities to fund Estyn for post-16 education and training inspections under the Tertiary Education and Research Act 2022 (£2.053m).
- Additional funding for delivery of the apprenticeships programme (£2.378m).

We anticipate further funding will be allocated to Medr for the costs of additional medical places, Higher Education Research Capital funding. Details of this funding will be confirmed with your team as soon as possible, and may be remitted within the financial year, subject to ministerial approval.

We look forward to our continued working with you and the Medr senior team.
